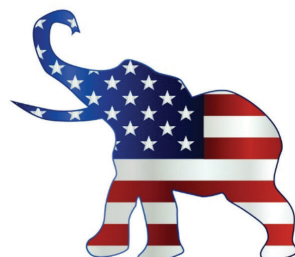

TEXAS SUPREME COURT, PLACE 2

A 6th generation Texan, Jimmy works hard to understand the law and apply it fairly and consistently to each case. He has authored over 100 opinions during his time on the Supreme Court. Jimmy knows a judge should apply the text of the law and the original meaning of the Constitution. As our Texas Constitution says *"All political power is inherent in the people, and all free governments are founded on their authority, and instituted for their benefit."* These words provide the foundation for Jimmy's approach to his work on the Supreme Court.

Before becoming a judge, Jimmy represented the State of Texas in courts across the country, fighting for our constitutional liberties and defending Texas against federal encroachment. Jimmy was appointed to the Court on January 2, 2018 by Governor Abbott. His commitment as a judge is to apply the law fairly and equally to every party who comes before the Court. In November 2018, Texans elected Jimmy to a six-year term on the Court. Jimmy considers his service on the Supreme Court an honor, a privilege, and a blessing. He hopes to continue serving the People of Texas for many years to come.

About the Texas Supreme Court

Composed of the chief justice and eight justices, the Supreme Court of Texas is the court of last resort for **civil matters** in the state. The Supreme Court is in Austin, immediately northwest of the state Capitol.

Supreme Court justices are elected to staggered six-year terms in statewide elections. When a vacancy arises the governor may appoint a Justice, subject to Senate confirmation, to serve the remainder of an unexpired term until the next general election.

Justices must be at least 35 years old, a citizen of Texas, licensed to practice law in Texas and must have practiced law (or have been a lawyer and a judge of a court of record together) for at least ten years.

TEXAS SUPREME COURT, PLACE 4

John Devine

JusticeDevineTX.com



Justice John Devine was first elected to the Supreme Court of Texas in November 2012. He previously served for seven years as judge of the 190th State District Court in Harris County and for nine years as an appointed special judge for the Harris County justice of the peace courts.

Justice Devine was elected in 1995 and re-elected in 1998 to the district court. During his tenure, he tried nearly 350 jury trials and presided over more than 500 bench trials. In 1998, he was voted well qualified by the Houston Bar Association. Justice Devine reduced his court's case backlog by more than 40 percent during his two terms. He was awarded the title of "Texas Size Hero" by Focus on the Family magazine.

In his private litigation practice since 2002, Justice Devine represented both plaintiffs and defendants in state and federal courts. In 2002, he was appointed as a special judge for the Harris County justice courts and served until 2011. Devine was also a member of the District of Columbia Bar Association, the Board of Civil District Judge Mass Torts Committee, Board of Civil District Judges, the Harris County Juvenile Justice Charter School Board and the Harris County Juvenile Board.

TEXAS SUPREME COURT, PLACE 6

Justice Jane Bland has served on the Supreme Court of Texas since 2019. Texas voters elected her in 2020 with over six million votes—the most a candidate for any elected office has received in Texas history. Justice Bland has over 25 years of experience on the bench—as a trial judge, an appellate justice, and now as a Texas Supreme Court Justice.

Justice Bland graduated at the top of her class in law and in accounting and honors business at the University of Texas at Austin. Following law school, Justice Bland clerked for the Honorable Thomas Gibbs Gee on the United States Court of Appeals for the Fifth Circuit.

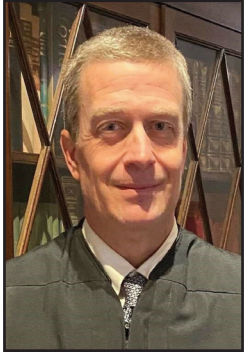
Throughout her career, Justice Bland has been recognized for her work to improve our state. In 2010, Chief Justice John Roberts presented her with the William H. Rehnquist Award, given to a state court judge who exemplifies the highest level of judicial excellence, integrity, fairness, and professional ethics. The Texas Association of Civil Trial and Appellate Specialists has recognized her as the judge of the year four times.

CRIMINAL COURT OF APPEALS, PRESIDING JUDGE

Justice David J. Schenck has built a reputation of integrity and independence throughout his expansive three-decade career as a tough but fair legal mind who calls them like he sees them, free of bias or outside influence. He led the Texas State Commission on Judicial Conduct, the Constitutional body that oversees the behavior of all judges in Texas. He is an ethical, principled stalwart who is applauded for standing up against cronyism and any form of the “pay for play” politics that are far too common today. He has also been honored with the State Bar’s highest award for pro bono legal service.

Appointed to the Fifth District Court of Appeals by Governor Rick Perry in 2015, Justice Schenck was elected to a full term in the largest appellate district in the state in 2016 demonstrating his ability to succeed in a tough election and to lead major battles over upholding the Constitution while on the bench. His track record leaves no doubt about his commitment to the Constitution, the rule of law, and the right of all Texans to an honest, competent, and impartial judiciary.

About the Criminal Court of Appeals

The Court of Criminal Appeals is Texas’ highest court for criminal cases.

The Court consists of a Presiding Judge and eight Judges. They are elected by the voters of the entire state, and they hold their offices for terms of six years.

After a trial court has decided a criminal case, the State or the defendant may appeal to a higher court.

The appeals of all cases in which the death penalty has been assessed come directly to the Court of Criminal Appeals from the trial courts. The appeals of all other criminal cases go to one of the fourteen Courts of Appeals in Texas, and their decisions may be reviewed by the Court of Criminal Appeals.


